# JENTAYU SUSTAINABLES BERHAD AND YAYASAN KEBAJIKAN SABAH PROVIDE FLOOD AID WITH TOTAL CONTRIBUTION OF RM 550,000

**KOTA KINABALU, SABAH, 10 January 2022** – JENTAYU Sustainables Berhad (“JENTAYU”) (formerly known as IPMUDA Berhad) in collaboration with Yayasan Kebajikan Sabah (YKS) has successfully raised RM 550,000 to assist the flood victims in Sabah at the **Flood Victims Fundraising Ceremony** (“Fundraising Ceremony”) which was held at the Sabah International Convention Center (SICC), Kota Kinabalu today.

JENTAYU sponsored the entire cost of the Fundraising Ceremony, while 100% of the donations received will be channelled directly to the Sabah Welfare Foundation Fund for flood relief purposes. JENTAYU has also made a direct contribution of almost RM400,000.00 for the same purpose.

The flood relief fund, which only began collections 3 days ago on 8 January 2022, has attracted many donors who collectively sought to provide assistance to flood victims in Sabah.

The total contribution of RM 550,000 will be channelled to more than 2000 victims through their head of household (*Ketua Isi Rumah*) registered at the Temporary Evacuation Centre within their district. The areas involved are Kota Marudu, Paitan, Beluran, Telupid, Sandakan and Pitas. The contribution from the flood relief fund will be used to assist with the provision of kitchen necessities, schooling needs of children affected by the floods and any further required necessities. On 3 January 2022, YKS had already distributed aid to flood victims in Kota Marudu and Pitas, and aims to begin providing assistance in Sandakan, Telupid, Paitan and Beluran.

YKS was established in July 2021 and is an initiative by the YAB Chief Minister of Sabah to increase and develop the socio-economic status of the people of Sabah towards a progressive and prosperous society.

The cooperation between JENTAYU and YKS is a noble effort that symbolizes the commitment of corporate bodies in improving the socio-economic level of Sabahans.

The director of YKS M, Puan Rugayah binti Ag. Besar said "YKS is very proud of JENTAYU's noble efforts to collaborate on this. We appreciate their humble invitation for us participate and host a successful Fundraising Ceremony for flood victims".



Holding the Fundraising Ceremony was a last-minute change based on concerns by JENTAYU's management who initially proposed to hold a launch event for the name change from IPMUDA Berhad to Jentayu Sustainables Berhad, as well as the launch of Sungai Maligan-Padas Hydroelectric Powerplant Project.

The event is in line with IPMUDA Berhad's renaming and rebranding to Jentayu Sustainables Berhad, fitting the company's mission and vision - A Sustainable Future for All. JENTAYU, now in its 47th year, has gone through a new ownership change and is now focused on developing renewable energy and sustainability projects as its main agenda. This is also in line with JENTAYU's aspiration to instil compliance and uphold Environment, Social dan Governance (ESG) principles.

Datuk Hj Beroz Nikmal Mirdin, JENTAYU's Executive Chairman and YKS Trustee, urged more corporate and private agencies to contribute in donating and relieving burdens felt by flood victims. Beroz, as a native Sabahan, also urged more Sabahans to return and contribute towards efforts to increase the local socio-economy.

"To all donors, we say thank you. JENTAYU takes note of the country's flood situation while still battling the pandemic and we have decided to replace our project launch event with a fund raiser, in the hope to jointly relieve burden of flood victims in Sabah.

"Next, as a sign of our commitment to Sabah's development, JENTAYU headquarters will move to Kota Kinabalu," added Datuk Hj Beroz.

The event that begun at 9pm was hosted by Daphne Iking and featured performances from acclaimed artists including Nikki Palikat (Gegarvaganza), Dato' Hattan and Dato' Awie.
